Additional information from Bowen, Rev. J.R., <u>Regimental History of the First New York Dragoons</u>, written in 1900. "The regiment started on Grant's campaign in 1864 with about four hundred carbines and in the Wilderness (at Todd's Tavern), having dismounted, made a desperate fight, *sustaining the*

heaviest loss of any cavalry regiment, in any one action, during the entire war, their casualties amounting to 20 killed, 36 wounded, and 35 missing; total, 91." Bowen also used the NYSAG rosters as I have but claims he corrected over 400 errors. If the dead at Andersonville are included in his tally above, that would make 38 to 42 dead, total, as a result of this one battle.
