21 of the men captured at Weldon Railroad are noted as "absent, sick" in various hospitals (primarily those at Camp Parole/Annapolis, MD) with no clear picture of their outcomes, such as No Pension Application Found/NPAF.

28 died at Salisbury between October 21, 1864 and February 15, 1865. Another man died at Richmond and another at Andersonville in January 1865. This makes a total of 30 who died in Confederate prisons as POWs.

2 men died in hospital at Camp Parole in October 1864---only around two months after being captured. In April, 1865, at least 3 men died in hospitals and 2 died at their homes while on furlough.

140 enlisted men are recorded as "captured." 2 of these joined the Confederate army.

6-10 men are listed as wounded/ missing in action. With one exception, the Yankee wounded do not appear to have been taken into captivity by the Rebels.

Lieut. Colonel Moffett, 1<sup>st</sup> Lt. Hawkins(Co. K), 1<sup>st</sup> Lt. Mesler (Co I), Captain Parsons (Co. A), and 2<sup>nd</sup> Lt. Thomas (Co. H) were captured.

Phisterer counts 2 killed, 6 wounded/recovered and 6 officers and 164 men captured. The discrepancy between his numbers and mine may possibly be explained by the numbers of recruits who entered the regiment on August 16, 17, and 18. A number of them are noted as discharged from hospitals, such as the examples below:

In addition, many of them had already been transferred from the  $83^{\text{rd}}$  NY to the  $97^{\text{th}}$  NY on June 7, 1864...

One may well imagine about 25 transfers and raw recruits going into panic and getting the better part of a veteran regiment captured as a result. But this is only a guess, at best. Further research needs doing. But this study hints at the attrition and lack of cohesion taking place in the Army of the Potomac at these desperate times, which is well-noted by generals and men elsewhere in the literature.

Death rates in and from Confederate prisons is difficult to determine here. Adding 21 indefinites to the 35 or so definites makes 56 and that takes the toll to about 40%, which is fairly common in better studies I've made than this one. Otherwise the rate becomes near 26% and this is possible, if not probable. The truth is probably in between, and about a third of the Union captured perished in or of captivity---here primarily from exposure and starvation at Salisbury.
