With very few exceptions, my copy and paste list from the NYSAG rosters and the more immediate newspaper list created by an unknown person (but most likely the regiment's chaplain) match to a great degree. The Official Records cites 42 killed/died of wounds which is also close to this study. 41 officers and enlisted men here nearly matches the 42 missing given by the Official Records. The great discrepancy comes in the 111 officers and enlisted men numbered by the OR as wounded and the remaining numbers here. In this case, it would appear that the newspaper list and the information given in the NYSAG roster deal only with the most seriously wounded. There are 182 names here total. By subtraction that means about 20 names of the most severe wounds are mentioned. Over 100 of the lesser wounded are not included (if we are to take the OR as entirely accurate).

Company F, with Captain Livingston wounded and captured and Lt. Stevenson killed, took the greatest number of wounded/captured/left on the field, along with 2 killed or about 12 of the most serious cases.

Company B, with 6 killed and 8 wounded/captured/left on the field, took the most serious casualties overall---14.

Neither Robertson nor Longacre have much to say about this regiment. Robertson does mention the "unauthorized" retreat of the 8<sup>th</sup> CT forward of the 118<sup>th</sup> NY that left them "flanked and also forced back..." Given the numbers of those left on the field, wounded, and subsequently captured, they would have fallen back in a hurry. But the numbers of those killed belies a simple five word summary, as do the numbers of those less gravely wounded. Prior to Fort Harrison, on September 30 and October 1, the men of the 118<sup>th</sup> were issued Spencer repeaters and put them to good use. General Burnham obviously trusted his Adirondack regiment to do the right thing and that fact should give them a little more credit in their part of the Drewry's Bluff debacle.
