Y.; also borne as Holster. [Died October 29, 1930 at Seneca Falls, NY]

Hoster, John L.. Correspondence of John L. Hoster, 1860-1867. 88 items

Hoster writes to his sweetheart, Josephine (Josie) Cole, describing action of the 148th in Virginia, particularly around Porthsmouth, Norfolk, Yorktown and Williamsburg. He discusses life in camp and frequently mentions low moral character of Union soldiers and Southern civilians. Several letters mention African Americans, including a description of a church service. There are references to the progress of the war and prominent generals. A letter to a Mr andd Mrs. Vincent concerns the death of their son, George, in Andersonville. Josie's letters describe daily life in Seneca County, N.Y. A few pre-war letters refer to schooling and one refers to "excitement about South Carolina and secession. Located at the University of Virginia.

Hoster, John L. John L. Hoster diary, 1862-1865.

The collection consists of a bound typescript copy (137 pages) of the diary of John L. Hoster with entries between September 22, 1862 and April 14, 1865. Hoster's diary chronicles his military service and imprisonment (June - September 1864), his move to Charleston and Florence, South Carolina, then to Goldsboro, North Carolina, and his exchange near Wilmington, North Carolina. There are regular daily entries, some of considerable fullness, during the months at Andersonville, giving details about food, health, morale, and general treatment at Andersonville. His comments are restrained and remarkably detached. He thought Savannah a pretty place and was grateful to the citizens of Charleston for their kindness to the prisoners, particularly the sick.

The fates of 4 additional men remain unknown.

In this case, about 40% died, and probably closer to 50%. The dead at Florence were buried in trenches and record keeping was poor. Estimates are that 2300 Union soldiers died there.

In the Official Records, I found no exact description of the incident that led to the capture of so many men from Company A. (See OR51, pt.1, p.1256) However, in the casualties list in the same OR volume, 24 men and 1 officer are counted as missing from the 148th NY and these numbers are almost exact for the total from Company A. As part of General Griffin Stedman's brigade testing the defenses of Petersburg, a reconnaissance party got too far out towards Harrison's Creek when the rest of the brigade pulled back unexpectedly. [The captors were probably the 26th Virginia. Ironically, at about 6:00 PM on the 15th of June, the 26th VA was captured by the 117th NY and 13th New Hampshire---211 men, 16 officers and 5 guns at Battery #5.]

In addition, I found the following: "In stark contrast at least some of the prisoners from Petersburg who also had arrived that day [at Andersonville prison] enjoyed unimaginable luxuries. Not only had Sgt. John L. Hoster of the 148th New York and his companions retained all their money, clothing, rubber blankets, canteens, cooking gear, and haversacks stuffed with food and coffee, they even had pup tents, which they snuggled in that night."

Their good fortune could be a mixed blessing. This excess of survival goods would surely have made them a target for "Raiders." Whatever goods this small group had with them, it did not mitigate their suffering much since the death numbers are similar to those of much larger (and better documented) groups of captives such as the 85th New York and 16th Connecticut who also came to Andersonville flush with cash and tradable/sellable equipment from their capture at Plymouth, NC, on April 20, 1864 and also the 60% dead from captivity experienced by the 9th Minnesota captured at Brice's Crossroads, Mississippi on June 10, 1864.
